Guidelines for Reviewers

Please, carefully read the information below, it may help you to review a research paper:-

1. **Carefully review the paper**
2. Your review should not be about what should have been done; rather it should be a critique of **what the author actually did.**
3. If you think paper is poorly written or the contribution is poorly described, **state that, instead of rejecting the paper on this basis, give your comments/ suggestions for modification.**
4. Don't review a research paper under the **time pressure.** Spare a little of your **valuable time to review** a paper properly.
5. **Review to accept papers**
6. When you read a paper, try to **find reasons to accept the paper**, you should spot what is good about the paper and highlight that in your review.
7. If you don't like the approaches, fine, but try to decide what about the author's paper makes it acceptable for publication, No doubt, all the papers are not worth publishing, but **almost all papers have an idea THAT** the author is promoting and **you should review to accept that idea.**
8. Sometimes, the idea is bad/wrong/ already been done and so paper can't be accepted. But read the paper looking for **a reason to accept** it.
9. When you write your review, write with the mind set "**how to improve this paper**".
10. **Write a Review**
11. Review form has option "Accepted or Corrections Suggested". Suggest your comments in Box that help the authors to improve his paper. Following should all be covered somewhere in your review:
12. Objective of the papers
13. Highlight the contribution of the paper as well as how significant it is.
14. State your recommendation and why
15. State ways to improve the paper
16. You should note the small things , but ideally place them at the end of your review in a separate section as "Details to improvement/ General Comments"

4. Things to avoid

1. Do not say "The author should add additional references or write on such pattern" **without actually write examples for desired pattern.**

Review Process

- Click on <http://socialresearchfoundation.com/new/signup.php>
- Go to Expert Paper List and find paper on right side panel.
- Click on Action Link and check the complete paper.
- Click on **Accepted** or **To Be Corrected** as per your suggestion for separate headings.
- At the end , if paper is completely accepted for publication, select "Accepted for Final Publication" or Select "Correction Suggested", then **Submit** it.
- You will get the Certificate of Reviewer Board on the same page after the publication of this paper.
- Your name will also appear on the Editorial Board of same issue of journal on our website www.socialresearchfoundation.com

Guidelines For Author

Your Research Paper should follow following guidelines:

1. **Abstract:** Please write abstract of your paper within 100 words in which a brief description of your research paper should be given.
2. **Keywords:** The important word should be written so that your paper can be traced on internet on the basis of those words.
3. **Introduction:** Describe your problem and state your contribution to the solution of the problem. From the very start be very clear about what you will be arguing in your paper.
4. **Objective of the Study :** First, clearly present the gist of your idea, what is the main problem / question that you are dealing with in this paper? What are the goals/objectives of your research? Why it is an interesting/ significant problem?
5. **Review of Literature:** Move on elaborating your idea with example and comparison. You may refer to previous research done on the same topic/pattern and explain how your work differs from and contributes to the existing literature.
6. **Main Text :** In case of theoretical paper, main content of the paper can be mentioned under this heading.
7. **Concepts and Hypothesis :** You may define the basic concepts that you frequently use in your paper. You should clearly state what your hypotheses are?
8. **Research Design:** Then explain your research methodology. What is your research base on/What kind of resources you have used. What is the universe of your study. What tools and techniques are used? Etc.
9. **Findings:** Describe the findings of your research paper. In other words what conclusion did you reach based on your research.
10. **Conclusion:** Briefly summarize the main text of your paper with findings. Put your suggestions if any.
11. **Suggestion:** Give suggestions based on your study.
12. **Footnotes:** All footnotes should be indicated by serial numbers in the text and literature cited should be detailed under Notes at the end of the chapter bearing corresponding number.
13. **Reference:** Place the reference at the end of manuscript following the footnotes. The list should mention only those sources actually cited in the text or notes. Author's name should be same as in the original source. More than one publication by the same authors should be listed in chronological ascending order. Following are some examples:

3. **Book reviews:** which require no abstract, must be in the following order: Name of author/title of book reviewed/place of publication/publisher/year of publication/number of pages, in Roman and Arabic figures to include preliminary pages.
4. **No dots** after abbreviations (UK, USA, MBBS, MBA etc.) Use dots after initials (K.C. Sethi).
5. **Capitalization** of headings/text should be kept to the minimum and should be consistent.

In writing a research paper maintain academic honesty. Be very careful to cite the sources that you use in your paper.

Please note that your paper will upto 5000 words within max 6 pages only (For Hindi Font Style must be **Mangal**, Font Size **10** in Single Spacing & for English, Font Style must be **Arial**, Font Size **9** in Single Spacing) with proper **Abstract, Keywords, Introduction, Aim of Study, Hypothesis, Tools, Result & Findings, Discussion & Suggestion Etc. and MLA Styled References.**

- Create your **Permanent Account** on <http://socialresearchfoundation.com/new/signup.php> once to check paper status, download payment receipt, softcopy of paper and certificates in future.
- Re-Login your account by clicking the above mentioned link and OTP received in your mail id.
- Come to Purpose and submit your payment details as well as complete paper in the respective headings through COPY+PASTE.
